

## **PLAIN LANGUAGE SUMMARY OF DAVIS COUNTY HOSPITAL FINANCIAL ASSISTANCE POLICY**

Davis County Hospital offers financial assistance to many people who have health care needs and are not able to pay for care. Davis County Hospital does not want a person's ability to pay their bill to stop them from getting care. This is a summary of the Davis County Hospital Financial Assistance Policy (FAP).

### **Availability of Financial Assistance**

You may be able to get financial assistance if you are not able to pay your health care bill. Davis County Hospital provides financial assistance to Davis County residents for non-elective medical services and non-Davis County residents for emergency services. Optional services, such as elective procedures, will not receive financial assistance. ### **Eligibility Requirements**

Total income of the people living in the home is used to determine if you will get assistance. If this income is below 200% of the Federal Poverty Level (FPL), you will not have to pay your hospital bill. Incomes between 110% and 200% of the FPL guidelines will receive a discount based on a tiered system outlined in the policy. Please refer to Davis County Hospital's full financial assistance policy for a complete explanation and details. After applying the financial assistance percentage to the patient's bill, the patient will not be responsible for paying more than what the calculated amount is according to the income guidelines as outlined in the Financial Assistance Policy.
